GENERAL DESCRIPTION OF WORK:

Fabricate two (2) 7,200 SF modular office buildings, which can be new or used (within 5 years old). Modular building contractor shall provide means to transport, lift and secure building to UCI designated site foundation and provide single points of connection for all utilities. The building should be within 150 miles maximum from the UC Irvine campus, and shall be currently installed in a location such that University staff may review the building in its place. The selected contractor shall provide all engineering necessary for a complete package to be approved by the University.

The license used to satisfy this requirement shall be of the same type required by the contract. The Contractor shall provide a minimum of 3 references for projects similar in scope and size to this Project which have been successfully completed in the State of California during the past 3 years.
